### Data Controller

Under United Kingdom data protection law, this is the organisation or person responsible for deciding how personal information is collected, stored and used.

Endeavours Partnership (owner and operator of SeriesBible) is the Data Controller for SeriesBible.

# Data Processor

A Data Controller may appoint another organisation or person to use some or all of your personal information in order to carry out certain tasks on behalf of the Data Controller.

Endeavours Partnership (owner and operator of SeriesBible) is both the Data Controller and the Data Processor for SeriesBible. Except as noted below, we do not outsource any business process which requires the sharing and processing of personal data with third parties.

The single exception is that our payment processor, Stripe Inc. - in common with all other online payment processors - may also collect information about you which it may store on its own servers for its own business purposes.

Endeavours Partnership (owner and operator of SeriesBible) does not have any control or influence over Stripe Inc.'s business policies and practices.

### **Identity Information**

This is information relating to your identity such as your name (including any previous names and any titles which you use), gender, marital status and date of birth.

#### Personal Information

In this Privacy Policy, we refer to your personal data as 'personal information'. 'Personal information' means any information from which a living individual can be identified. It does not apply to information which has been anonymised.

We are only able to use your personal information for the reasons set out in data protection law. There are legal reasons incorporated in British data protection law other than those listed below but Endeavours Partnership ( owner and operator of SeriesBible ) only uses your personal information for the following legal reasons ...

**Contract Reason**: in order to perform our obligations to you under a contract we have entered into with you
